Prodaja se bo izvedla z javnim zbiranjem ponudb, ki bo potekalo do 15.4.2009 in se bo po odločitvi prodajalca, Neos svetovanje d.o.o. lahko zaključilo z izbiro najugodnejše ponudbe, pogajanji ali dražbo.

Opportunity

The investment opportunity consists of the sale of 58.270 common shares or 25,41% of KG Rakičan d.d., the holding company of Panvita Group.


The transaction is being done through a public tender process that closes on 15 April 2009. After review of the bids received, the seller, Neos svetovanje d.o.o. may decide to conclude the selection process by selecting the highest bid, further negotiation or by an auction.

Skupina Panvita

KG Rakičan d.d. je obvladujoča družba skupine Panvita, ki vključuje podjetja v treh stebrih: kmetijstvo in trgovina, energetika ter meso in mesni izdelki.

Deset podjetij skupine se ukvarja z okolju prijazno predelavo hrane in sonaravno revo živali. Preko 600 delavcev v skupini združuje dejavnosti poljedelstva, povrtninarstva, vinogradništva, kmetijske trgovine, reje prasičev, perutninarnarstva, veterinarstva, proizvodnje krme, energetike, predelave mesa in proizvodnje mesnih izdelkov.

Panvita Group



KG Rakičan d.d. is a holding company, owning majority stakes in nine daughter companies, organized in three sectors: agriculture and trade, energy and meat and meat products.

The group is focusing on environmentaly friendly food production and animal husbandry. Over 600 employees manage operations in agriculture, vegetable production, viticulture, agricultural trade, pig and poultry farming, veterinary services, fodder production, energy and meat and meat products.

Poslovni rezultati

Skupina Panvita proizvede letno 35.000 ton poljedelskih proizvodov (14% tržni delež v Sloveniji), 59.000 ton krmil (12% tržni delež), vzredi 120.000 prašičev (25% tržni delež) in 2.500.000 piščancev (11% tržni delež) ter proizvede 14.660 ton mesa in mesnih izdelkov (15% tržni delež). Z več kot 2GW proizvodene električne energije je skupina proizvedla 30% zelene energije v Sloveniji.

Skupina Panvita je kot prva v Sloveniji zadostila zahtevam standarda IFS (Internation Food Standard), ki je namenjen ocenjevanju dobaviteljev v živilskopredelovalni industriji. Na nivoju skupine je vzpostavljen sistem vodenja kakovosti, skladen z ISO 9001 (formalno je certificiranih pet družb), kakor tudi sistem preventive in upravljanja tveganj v proizvodnji hrane HACCP (Hazard Analysis and Critical Control Point).

Facts and figures

Panvita group produces over 35.000 tons of agricultural products yearly (14% market share in Slovenia), 59.000 tons of fodder (12% market share), 120.000 pigs and 2.5 million pieces of poultry (25% and 11% market shares), as well as 14.600 tons of meat and meat products (15% market share). More than 2GW of produced electricity place Panvita group at 30% share of all »green« energy produced in Slovenia.

Panvita is the first organization in Slovenia to receive IFS (International Food Standard) certification, aimed at rating of suppliers in Food processing industry. The group also maintains ISO 9001 quality management system across the group (5 companies maintain formal certification) as well as HACCP (Hazard Analysis and Critical Control Point), a nutrition safety management system.
